- 2. Currency After signoff, each member must meet the following currency requirements to fly the Arrow without a CFI:
 - a. Have 3 hours logged time in a Piper Arrow within the past 180 days, OR b. Have a Club instructor checkout and sign off in the Club's Piper Arrow within the past 45 days.
- 3. Club CFIs Active members who are CFIs and CFI-Only Associates:
 - a. Must have logged 5 hours in Piper Arrows before instructing in the Club's Arrows.
 - b. Are not subject to currency requirements when instructing.
 - c. Active Member CFIs must meet Initial and requirements (Nos. 1 & 2 above) when flying the Arrows for personal use.
